Emeritus professor Mel Ainscow (United Kingdom) will have the opening lecture: «Promoting Inclusion and Equity within a National Education Service: Barriers and Opportunities» at 5pm – 6.30pm (Aula 300)

Professor Mel Ainscow is Emeritus Professor of Education at University of Manchester (UK), and co-director of the Centre for Equity in Education. Worldwide he is a well-known researcher, active writer and his research is widely cited. Professor Ainscow's work attempts to explore connections between inclusion, teacher development and school improvement. Between 2007 and 2011 he was the Government's Chief Adviser for the Greater Manchester Challenge, a 50 million pound initiative to improve educational outcomes for all young people in the region. He was director of a UNESCO Teacher Education project on inclusive education which involved research and development in over 80 countries, and among others has been a consultant to UNESCO, UNICEF and Save the Children.

At 23rd and 24th October there are public lectures and roundtable discussions of experts from different European countries.
